Thank you for allowing us to speak about a historical piece of land in Gwinnett County that holds a special place in our hearts for many reasons. The Promised Land – Maguire/Livsey Home has a unique history like no other. It is a treasure that Gwinnett County has this land. It tells the story of Gwinnett County and of two families that loved their home and land, raised their families, and devoted themselves to growing and bettering their community.

In 1993, we discovered the story of the Maguires while doing family research. We documented our findings into a family history book that we donated to the Gwinnett Historical Society in 2016. It was amazing when we discovered that the home built by our GGG Grandfather Thomas Maguire was still standing and that the cemetery where the family is buried was still visible. We also discovered the reason why the home still existed and why the name of the Promised Land was still being used for the community – Thomas Livsey and his family.

We met and talked with Mr. Livsey many times over the years, and he expressed to us that he wanted to preserve his own family history and the history of Thomas Maguire. It was a privilege to meet Mr. Livsey and learn of his dedication to this project. He also contacted us to express his disappointment that the project of preserving the home had not been started.

What makes The Promised Land – Maguire/Livsey House so special and unique is its history. It was one of the oldest homes in Gwinnett. Thomas Maguire acquired the land in around 1820 and kept detailed journals of life on the land and those that lived there. One of the journals used in our research is located at the Atlanta History Center. Maguire wrote about the community and the people in the community. His journals described The Civil War, the troops on his land, the destruction around him, and his world after the war. Through preserving the stories of The Promised Land and the families that lived there, we can glimpse at the realities of life during that time.

The story of the home did not end there... The Promised Land's history continued when the Livsey family purchased the home.

We are often asked how we would like to see the home presented. It's hard to find words to express our feelings about this because of the sensitive and complex history.

The whole history of the home should be told and presented. The good and bad. All of it is a part of historical record and should not be erased or forgotten. It is Gwinnett's history that students in the future should learn about. Every person that lived on the land is an important part of the settlement and building of Gwinnett County. This includes the men, woman, and children of the Maguire family AND the slave's families that lived on the land.

The complete story should be told and presented. There would be no story if the Thomas Maguire story was eliminated. The house and the Maguires' story provide the cornerstone of the Livsey story. Without the Maguire story, the Livsey story would not have the significance that it has. What makes the whole history of the home complete is the Livsey family story.

The first proposal we were approached with was to have reproductions made of the furniture that are still in the family when Thomas Maguire lived there. We provided pictures of original Maguire furniture pieces that are currently owned by family members. We never heard updates on that project.

Ruth Abram told us she would like to project pictures on the walls of the home showcasing what the home was like during the time of the Maguires and the Livseys. We thought that would be a wonderful way to present both families and two totally different times in history.

The Maguire story has been documented in at least 6 or 7 books that we know of including the Historical Fiction Book Mary Amazon written by Janine Crist. Janine is a descendant of the Maguires and researched using Thomas Maguire's Journal. Janine wished she could be here today, but she is with her daughter who is recovering from cancer in Athens, Georgia. The book documents how the Promised Land and Thomas Maguire were part of Gwinnett and Atlanta History.

I can't think of a better way to present the Promised Land Maguire/Livsey home restoration project than embracing the words of Dr. Martin Luther King in his I Have a Dream speech. Standing in the shadows of Stone Mountain. There is a Promised Land for two families. The families of former slave owners and the families of former slaves join together to tell the history of a family coming to this piece of land in Gwinnett

County, building it into a community where people live in thrive to this very day. And it can be a project of education, preservation, and bringing unification.

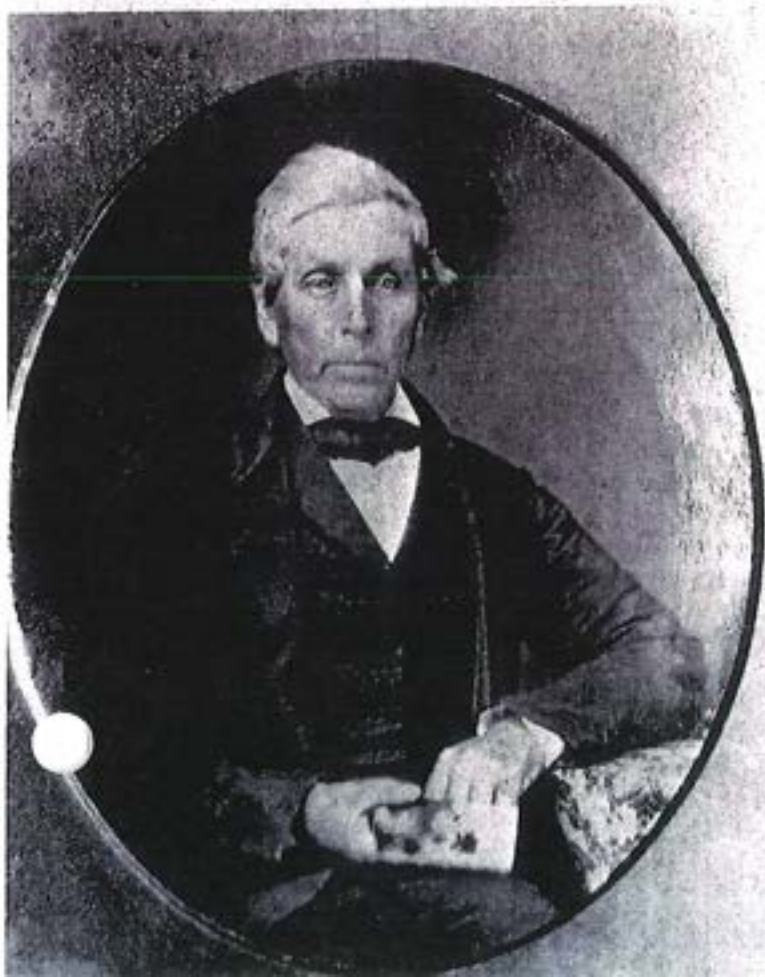

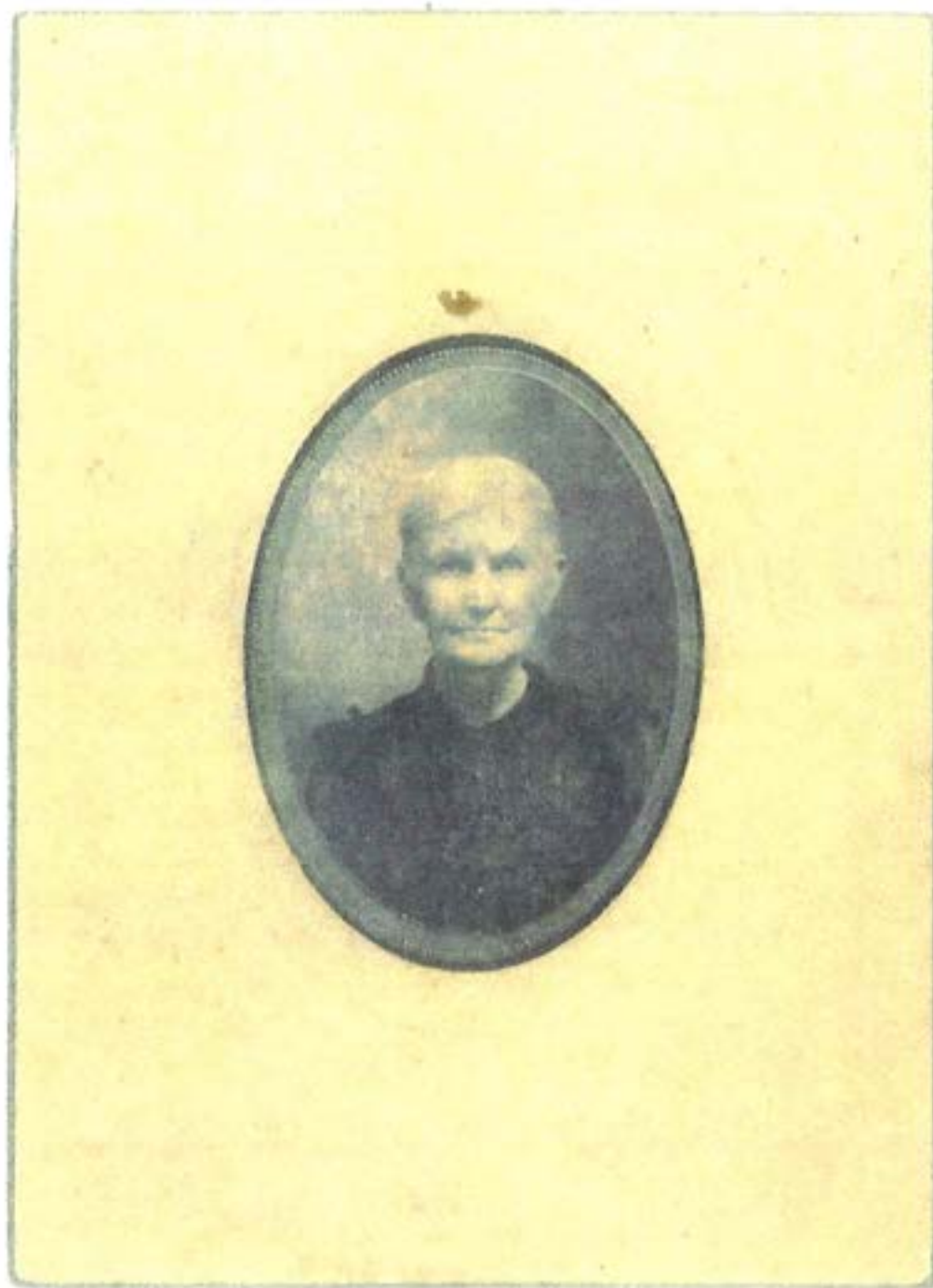

The son of Margaret and James Mullin, James Mullin II at the age of 21 became a locomotive engineer. He maintained this position during the Civil War until 1872. Thomas Maguire often rode with him from Stone Mountain and Lithonia to Atlanta and Augusta and mentions this many times in his farm journal.

John E. Maguire owned a thread factory called **Osceola Cotton Mills** on the Yellow River in Gwinnett County Georgia. He made the first cotton bagging produced in the United States. Later he changed to Jute bagging.

As a sideline he was a surveyor. He also had a tanning yard and a cotton gin, shoe shop, chair factory, mill for grinding corn and wheat and a blacksmith shop.

John received wounds during the civil war. Thomas Maguire traveled by train to Richmond, Virginia to see about his son and bring him home to Georgia.



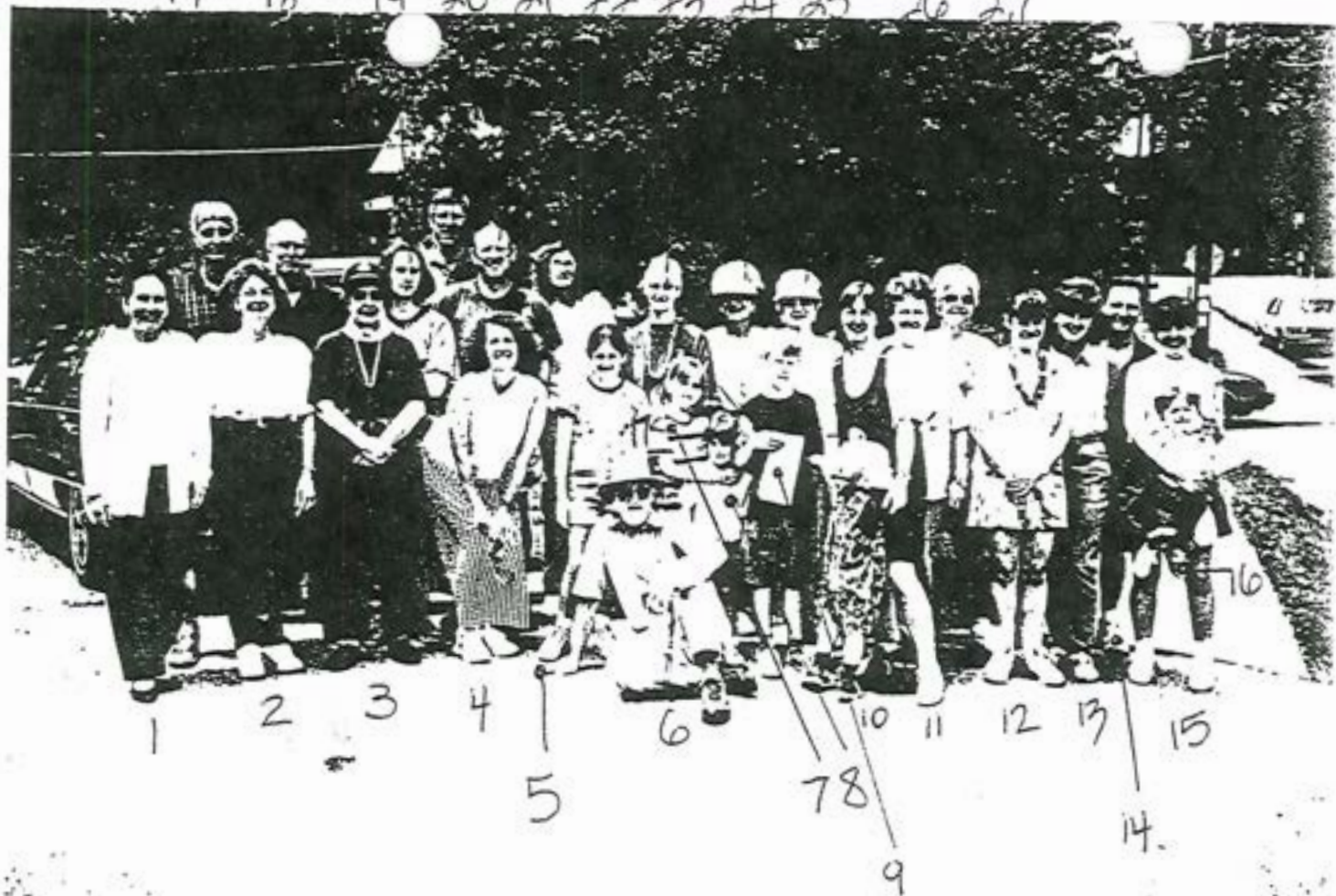

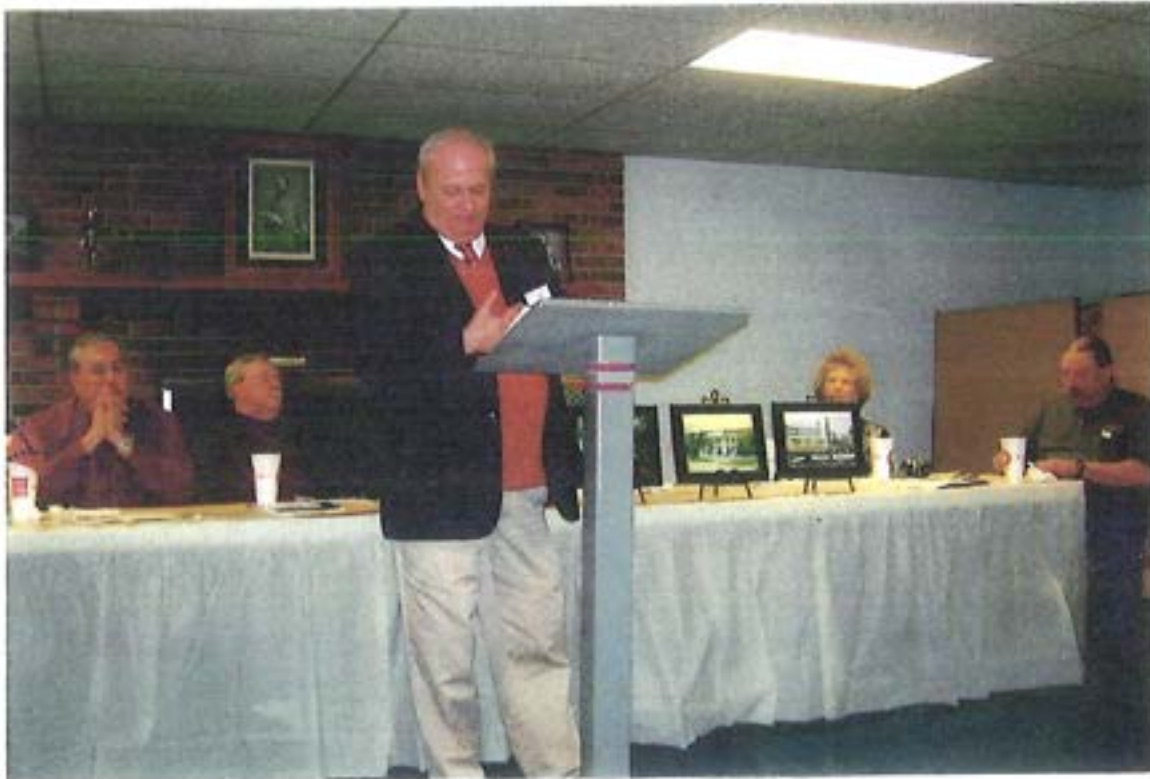

THOMAS MAGUIRE

On a slab in an Augusta, GA cemetery is this inscription: "Sacred to the memory of James Maguire, a native of Dundock, (Dundalk) Ireland who emigrated to America on 12/20/1825, and died 7/20/1828 after residence in this city 2 years and 7 months. Age 62 years."

The *Augusta Constitutionalist* dated 8/29/1828 carried this notice, "Died in this city on the 20th inst. of a lingering illness, which she bore with Christian resignation, Mrs. Catherine Maguire, in the 60th year of her age, the consort of the late Mr. James Maguire."

These were the parents of Thomas Maguire (10/1/1801-11/25/1886) who had come to America in 1818.

The 1820 land lottery of Gwinnett shows a fractional lot (351 in Fourth District) drawn by Thomas Maguire. It is bounded, on its irregular southeastern side, by the Hightower Trail which divides Gwinnett and DeKalb counties and contained about 50 acres. It is bisected by the Yellow River. This tract was probably the first unit of the 959 acres acquired by Thomas Maguire and held in his name in 1860.

He not only had this property, which he called "Promised Land," but also 26 slaves. His house still stands. It is plantation plain style, two stories, chimneys at each end with a porch across the front. Although it has been altered,

the original design can be detected. It is located on Hwy 124 between Lithonia and Centerville, a short distance from Yellow River. A grove of elm trees is in front of the house.

Thomas Maguire had in his possession some fine pieces of furniture brought by his family from Ireland. Two of these, a desk and a table, are now owned by a descendant in DeKalb Co.

In 1837 Jane died from blood poisoning. Tradition is that she scratched her leg on a pin in her clothing while dismounting from her horse. Next year, according to a family story, Jane's sister Elizabeth Anderson (10/21-1821-3/11/1881) felt so sorry for her sister's motherless children that she married their father. Thomas Maguire's house became an election precinct in 1834. He was a road commissioner from the Rockbridge District in 1836 and represented Gwinnett in the state legislature in 1838.

When Gwinnett was required to furnish volunteers to remove the Cherokees in 1838, Maguire was a second lieutenant in Hamilton's company.

Thomas Maguire was postmaster of the Rockbridge Post Office 1839-65. An excerpt from his farm journal and diary, 8/30/1860 reads, "Up before the sun. I will have to make up the mail this a.m., then carry it to Lithonia, then back and distribute it to the different claimants."

In 9/1849, he was one of the appraisers of a toll bridge, known as Rockbridge, over the Yellow River. The bridge was bought for \$45 and made public.

On 8/2/1859 he wrote: "After early breakfast in company with B. P. (son-in-law, Benjamin P. Weaver) in buggy for Lawrenceville. Got there at 9 1/2 o'clock. Place not much altered."

The General Assembly of 1870 provided for a system of public schools in GA. The first county board of education included Thomas Maguire.

He was a religious man born into a Roman Catholic family. Although he became a member of the Universalist Church, the faith of his in-laws, his diary tells of the family attending other churches in the area, especially Rockbridge Baptist. A charter member of Masonic Lodge No. 84 of Lithonia, he was also active in the Sons of Temperance.

EXCERPTS FROM MAGUIRE DIARY

Thomas Maguire's diary, which a descendant bequeathed to the Atlanta Historical Society, contains brief daily entries which usually begin with a comment on the weather:

"7/16/1859—Clear this morning. All hands hoeing. Elizabeth [wife] still improving. Marritt [slave] still on sick list.

"7/17/1859—Sunday, clear. John, the two Marys and Sarah Edney went to a singing at Mountain Creek Church and did not return until near sundown.

"8/18/1859—Still pleasant weather. Hands employed as yesterday. John E. [son] stopped going to school.

"1/1/1860—Sunday. Thermometer at 22°. There is considerable snow to be seen on the housetops and other places.

"12/24/1860—Cool and cloudy. Hands hauling rails for new ground fence. John and B. P. gone to Lawrenceville to hear Cobb speak. [Howell Cobb of GA had resigned 12/8/1860 as secretary of the treasury.]

"4/13/1861—Fort Sumter was attacked at 4 1/2 o'clock yesterday morning.

"5/7/1861—John E. [son] and I started for the mountain. He is going to Atlanta to get his uniform and drill...

"5/21/1861—After early breakfast started with John E. to the Mountain. Got there in good time in company with David, Mr. Smith and Mr. A. Martin and two other volunteers. They got on cars and off for war and we for Lithonia and home. God preserve the volunteers.

"6/6/1861—Letter from John E. and one from Thomas Jefferson [another son]... from Little Rock, AR.

"8/21/1861—News of the death of our son Thomas Jefferson at Pocahontas, AR on the evening of 8/4/1861.

"7/4/1862—Heard that our son John E. Maguire was wounded in battle. Off to Richmond. [Maguire was with Co. F, 8 GA Regiment, Anderson Brigade, Hood's Division]."

[The Union army's General William T. Sherman advanced to Atlanta by September 1864 and on to Savannah by Christmas. Southerners were horrified at the tales they heard of the ruthless march through GA. Desperation pervaded the South.]

"11/1/1864—My plantation is now in a bad fix. I do not know what damage is done yet.

"11/17/1864—I am now engaged in gathering up the fragments of the spoils. It is useless to try to record the destruction of the property, still I hope we can live...

"12/20/1864—Got mail from Lawrenceville with letters from John E. and James H. C. Both well.

"12/29/1864—Savannah gave up sure enough. We have a report that Captain Weaver is dead... [This son-in-law was killed 11/30/1864 at the Battle of Franklin, TN.]

"12/31/1864—I hope that in the new year we will have better times and better news." [The war ended April 1865.]

Thomas Maguire's "Promised Land" now lay in ruins, and two members of his family had died in battle.

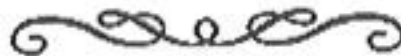

MARY JANE MAGUIRE

Mary Jane MAGUIRE (22 Aug 1832 Gwinnett – 28 Mar 1913), dau/Thomas MAGUIRE and Jane ANDERSON, who lived in the Promised Land, in the Rockbridge GMD, m 30 Jan 1851 Benjamin Putnam WEAVER (6 Jun 1831 – 30 Nov 1864). He was a captain in Company B, 42nd Regiment, Georgia Volunteer Infantry, CSA, who was killed in battle at Franklin TN, where he is buried. After Benjamin's death, Mary Jane lived in a home her father built on his Promised Land Plantation. Later, she lived with her son, Reuben L. C. WEAVER, on the Weaver Farm in Rockbridge GMD. She later moved to Atlanta (1891 – 1896) to live with her son, John Jefferson Putnam WEAVER, and his family. John was a conductor on the Georgia-Pacific Railroad and lived on Marietta Street in Atlanta in the 1800s. The family moved to Collingsville AL, where they appear in the 1900 Cleburne Co AL census. Mary Jane is buried in AL. Issue:

- L. Mary Elizabeth Eleanor WEAVER (8 Nov 1851 Gwinnett – 30 Jul 1906 Milton Co) m 24 Dec 1865, Gwinnett, Milton Hampton TRAMMELL (14 Jun 1836 Milton Co – 17 Feb 1915 Milton Co). Both are bur Old Big Creek Cem, Alpharetta, Fulton Co. Milton was a lieutenant in Company C, 42nd Regiment, Milton Co, CSA, and was wounded at the Battle of Resacca. WILLIAM T. WITHERS

Looking for a place in Florida to build a retirement home, William T. Withers bought a plot of land next to Starke Lake and constructed a two-story house. A veteran of the Mexican and Civil War, General Withers was very involved in the Christian faith throughout his life. Every Sunday he had a carriage sent into Orlando to bring the preacher to Ocoee. Services were held in the front room of his home. With Bluford Sims donating the land and Withers providing the building materials, they built the Christian Church in Ocoee, the oldest Christian church still in use in Florida. Withers died in 1889. His wife and family remained in the house until 1910 when they sold it to another early settler, David O. Maguire. Maguire and his brother James did much to cultivate the citrus industry in central Florida by encouraging friends and family to the area. Families such as the Minors, the Seegars, and the Eckles came to Florida at the bidding of the Maguires. After Maguire past away a few years later, his wife Margaret lived there until her death in 1943. The City of Ocoee acquired the Withers-Maguire House in 1984, and three years later it was listed in the National Register.



After visiting central Florida for one winter, William T. Withers moved to Ocoee and built a home next to Starke Lake, now known as the Withers-Maguire house.

David O. Maguire was born in Guinnett County, Ga., Oct. 16, 1878.

His father at that time was considered one of the substantial men of his county. At the close of the Civil war, fifteen years later, conditions were changed, slaves all free and almost everything gone but the land. Notwithstanding, he managed to attend Conyers Academy, Conyers, Ga., and after finishing there he taught school near his home for two or more years before he decided to attend the State University, Athens, Ga.

Temperate in his habits he made a good student. He finished his education from Ben Hill, the noted Georgia Senator. He received a military training at the same university.

Upon finishing his education at this place he accepted the position of principal of the High School of Loganville, Ga., where he taught for several years.

He was married to Miss Margaret M. Francis, also a college honor graduate, Jan. 7, 1888.

His health failing, he decided to come to Florida and engage in orange culture. This occupation at that time was very alluring and promised a fortune in the near future.

James Maguire, an older brother, came with him. They toured the State in a light two-horse buggy, finally deciding to buy land near Lake Apopka, now known as Crown Point, to

which place he brought his family two years later.

He bought the Pennington Grove in 1890, where he moved the same year. The freeze of 1891-2 killed his groves to the ground, but he sagaciously went to work to bring them back to bearing.

He was instrumental in bringing about the Citrus Exchange, together with T. J. Minor, built and equipped the Exchange packing house at Ocoee, and was president of the Exchange at that place. He never tired of doing what he could to help the community in which he lived. As a man he was honest and reliable and thoroughly ethical. He was a close student of politics and helped organize the People's Party and attended the convention when the platform was adopted.

He gave his five children, four sons and one daughter, the advantage of a college education. The oldest, Dr. Thomas C. Maguire, now has a good practice at Plant City; Charles Hugh Maguire graduated from the State University at the same time as his brother and went to Washington and Lee to study law, but died suddenly of appendicitis on February 6, 1911; Fred H. Maguire, at Ocoee, and Rayner E. Maguire, attorney at law, Orlando, Fla.; Lillian Irmer, a student at Tallahassee, Fla.

At the age of 63, November 9, 1913, Mr. Maguire went to sleep on the night of the eighth, never to awaken. His death was a shock to his family because to unexpected.

The amounts paid to John E., James H.C., and David O. to be considered as that much paid to them of their respective shares.

4th Item - Should my estate at the winding up of the same be sufficient in amount to pay to each of my second wife's children one thousand and eighteen (\$1018.00) dollars, the amount I paid to each of my first wife's children, what is over that amount, if any, to be equally divided between all my children.

5th Item - I do hereby constitute and appoint my sons, John E. and William A. Maguire as my executors of this my last will and testament.

Given under my hand and seal this the 3d day of April, 1882.

James MAGUIRE and Catherine MURPHY were from Dundalk Northern Ireland and were members of the Roman Catholic Church. After living there for almost 3 years they both died a month apart of Yellow Fever.

Thomas Maguire and family information

Thomas Maguire arrived in Augusta, Georgia via Savannah, Georgia in 1820 at the age of 19. He settled in Augusta. Thomas Maguire took a course in short hand while living in Augusta Georgia. The name of the school Thomas attended was Strong and Coe Stenography School. In the Augusta Chronicle Newspaper dated December 23, 1822 it was stated "We the subscribers having attended the Writing School of Messrs. Coe and Strong in this city..." this notice listed the students who had graduated – Thomas Maguire was one of the graduates listed. This is where he learned short hand, which he used in his farm journals that are now at the Atlanta History Center.

Thomas participated in the land lottery in the newly created (in 1818) Gwinnett County where he drew a 40 – 50 ace partial lot in the very southern tip of the county bisected by the Yellow River. The 1820 land lottery of Gwinnett shows a fractional lot (351 in Fourth District) drawn by Thomas Maguire. It is bounded, on its irregular southeastern side, by the Hightower Trail which divides Gwinnett and DeKalb Counties and contained about 50 acres and is bisected by the Yellow River. This tract was probably the first unit of the 959 acres acquired by Thomas Maguire and held in his name in 1860. He not only had this property, which he called "The Promised Land," but also 26 slaves. His house still stands. It is a plantation plain style, two stories, chimneys at each end with a porch across the front. Although it has been altered, the original design can be detected. It is located on Hwy 124 between Lithonia and Centerville, a short distance from the yellow river. A grove of Elm trees is in front of the house. Thomas Maguire had in his possession some fine pieces of furniture brought by his family from Ireland, two of these a desk and a table are now owned by descendants in DeKalb County Georgia.

Thomas Maguire became a naturalize citizen of the United States on 23 Nov 1825. Sometime between the years of 1825 – 1830 Thomas and his brother James Patrick moved to Gwinnett County.

Thomas Maguire was a 2nd Lieutenant under the command of Captain Matthew J. Hamilton, in the removal of the Cherokee Indians in the Indian Wars; this was when Gwinnett County was required to furnish volunteers to remove the Cherokee Indians. Hamilton's company was mustered into service May 16, 1838 by Major M. M. Payne. During the Cherokee Land Lottery, Thomas Maguire drew land lots in the Sixteenth District, 2nd Section #383.*

During the Civil War when the Northern Army came through Gwinnett County, a great deal of foraging was done. Reports were made by the officers commanding the foraging expeditions. It is said that several Yankee Soldiers were killed by 2 of the Maguire boys, then only 12 and 14 years old.**

Thomas Maguire's house became an election precinct in 1834.

He was a road commissioner for the Rockbridge District in 1836.

Thomas Maguire represented Gwinnett in the State legislature in 1838. At that time the Georgia State Capital was located in Milledgeville, Georgia.

Thomas Maguire was postmaster of the Rockbridge Post Office in 1839 – 1865 and excerpt from his farm journal and diary, 8/30/1860 reads, "Up before the sun. I will have to make up the mail this am then carry it to Lithonia, then back and distribute it to the different claimants."

In 9/1849, he was one of the appraisers of a toll bridge know as Rockbridge over the Yellow River. The bridge was bought for \$45 and made public.

On 8/2/1859 he wrote, "After early breakfast in company with BP (son-in-law, Benjamin P. Weaver) in buggy from Lawrenceville. Got there at 9 ½ o'clock. Place not much altered."

The General Assembly of 1870 provided for a system of public schools in Georgia. The County Board of Education included Thomas Maguire.

Thomas Maguire was a religious man born into a Roman Catholic family. Although he became a member of the Universalist Church, the faith of his in-laws, his diary tells us of the family attending other churches in the area, especially Rockbridge Baptist. He was a charter member of the Masonic Lodge # 84 of Lithonia, and he was also active in the Sons of Temperance

Mary Jane MAGUIRE (b 22 Aug 1832 Gwinnett County Georgia – d 28 Mar 1913 Alabama) Mary Jane was the daughter of Thomas Maguire and Jane ANDERSON.

Benjamin Putnam WEAVER (b 06 June 1831 Gwinnett County Georgia – d 30 Nov 1864 Franklin, Tennessee in the Civil War Battle of Franklin, TN) Benjamin Putnam Weaver was a Captain in Company B, 42nd Regiment, Georgia Volunteer Infantry, Confederate States Army (CSA).

The Maguire Plantation was located near the Weaver Plantation in the Rockbridge District of Gwinnett County Georgia.

Mary Jane and Benjamin Putnam Weaver lived in a home close to the Promised Land. While Benjamin served in the Civil War, Mary Jane and her family took care of soldiers at her home. She cared for Confederate Soldiers on the front veranda of her home that were wounded when the Yankees came through their property. The wounded soldiers were placed on mattresses on the veranda in the shade and were fanned with pea fowl brushes and peach tree spouts. Like her father, Thomas Maguire, knowing that the house would be searched, she locked the trunks and dresser drawers. But the Yankee soldiers broke the locks and took jewelry, food and other items.

He was also the Mayor of Loganville, Georgia. At his death the Loganville newspaper stated that "it was the longest funeral procession ever seen in Loganville". In 1907 the mercantile corporation of Weaver, Tuck and Co. was organized with RLC WEAVER as president, which position he held at his death. He was also a director of the Farmers and Merchants Bank and was largely instrumental in the up building of that institution. He belonged to the Masonic Lodge.

WEAVER TRAMMELL and her husband Milton Hampton TRAMMELL. She took back the name of
Mary Jane WEAVER. After her divorce Mary Jane lived in a house her father, Thomas Maguire, built on
the Promised Land Plantation. Later, she lived with her son Reuben L. C. WEAVER on the Weaver farm
in Rockbridge GMD. She later moved to Atlanta (1891-1896) to live with her son John Jefferson Putnam
WEAVER and his family. John was a conductor on the Georgia Pacific Railroad and they lived on
Marietta Street in Atlanta in the 1800's. The family moved to Collinsville, Alabama where they appear in
the 1900 Cleburne County Alabama Census.

Following the divorce of Mary Jane and George Brewer, their daughters Enular Jane and Eugenia

Milton Hampton TRAMMELL (b 14 June 1836 Milton Co Georgia – d 17 Feb 1915 Milton County Georgia, buried at Old Big Creek Cemetery, Alpharetta, Georgia)
Milton Hampton Trammell served in the Confederate States Army (CSA) and as a citizen he was held in high esteem and served his county as road overseer, road commissioner, jury advisor and school trustee.

Milton Hampton TRAMMELL's Military Service Information

Milton Hampton Trammell volunteered for the Confederate States Army (CSA) on 04 March 1862 in Alpharetta Georgia for a period of 3 years or the duration of the war. Milton Hampton Trammell and his future father-in-law Benjamin Putnam Weaver both trained at Camp McDonald located at Big Shanty (Kennesaw Mountain) for approximately 5 weeks. Benjamin Putnam Weaver was part of the 42nd Regiment, Company A, known as the "Gwinnett Beauregards". Milton Hampton Trammell was a private and later became a lieutenant in Company C, 42nd Regiment, Milton County, Georgia, known as the "Milton Tigers". The 42nd Regiment, Georgia Volunteers, was officially mustered into the Confederate Army on April 11, 1862 and left Big Shanty on April 16, 1862. Milton Hampton Trammell served in the battle of Vicksburg Mississippi and he was wounded at the battle of Resacca in Resacca, Georgia and was captured. Milton Hampton was held prisoner at Johnson's Island Prison in Ohio on Lake Erie, and was released on June 16, 1865. It has been passed down in the family that at the end of the war, he was released, and traveled by train to Kennesaw Mountain Georgia and walked back to his home in Alpharetta, Georgia. Milton Hampton Trammell attended Civil War reunions in Alpharetta, Georgia, Atlanta, Georgia and other locations. Milton Hampton Trammell's grandson, James Milton Mauldin Sr. (James Mauldin) remembers visiting the Confederate Soldiers Home in Atlanta, Georgia with his grandfather.
