



Euthanasia April – June 2024

- 219 Animals euthanized
 - 216 Animals euthanized (April June 2023)
- 72 Unassisted deaths*
 - 49 kittens, 5 cats, 5 dogs, 9 puppies, 2 mammal, 1 fowl and 1 marsupial

*Includes unassisted death-in foster and transit

Bites and Rabies Comparison April – June 2024

Process of a Reported Bite

Most reported through 911. Gwinnett Police is dispatched along with AWE and usually Gwinnett Fire. When on scene, ACO is to ensure scene is safe and animal(s) are secured before gathering any information.

ACO obtains victim(s) information (name, DOB, address and phone number) and photos of the injuries along with information for the owner of the animal(s) involved. Citations issued to the owner, if warranted.

ACO is to have a form signed for 10-day vet quarantine. Home quarantine is approved by management only. If the injuries sustained require medical treatment at a hospital, the animal may be impounded with a waiver of liability form signed by the owner to protect the public.

Animal(s) involved are held for 10 full days to ensure they do not show any signs of rabies. If the animal(s) does show signs of rabies, the Bite Officer contacts the owner. If euthanized, the specimen is sent for rabies testing. If positive, the state lab contacts the Bite Officer who informs all involved parties/staff.

An Emergency Department is only place to receive rabies vaccines for a human at the expense of the victim.



Rescues, Neglect/Court, & Probation April –June 2024

Hoarding Case – Pomeranian

- Initial call pertained to breeding of rottweilers.
- Discovered seven nursing Pomeranians and two Rottweiler puppies at 10-weeks old.
- Citations issued and person denied having other animals.
- AWE follow-up inspection, learned puppies died and upon further inspection found plethora of dogs in unsanitary conditions.
 - All animals impounded that day.
- Animals impounded: one feline, 54 canines (two rottweilers and 52 Pomeranians).



Hoarding Case - Chihuahua/Dachshund Mixes

- Complaint from Fire Services responding to assist on a call concerning a fall.
- Fire Services advised conditions inside home were deplorable with 20 canines and they were almost unable to go inside without taking off the door hinges.
- AWE Special Operations Officers followed up with Fire Services after devising a plan and contacting necessary departments for assistance.
- Animals impounded: 18 canines (Chihuahua/Dachshund mixes)



Animals Rescued That Are Thriving April – June 2024


