

# Value Offset Exemption




Market Value

**Taxable Value** 




# **Property Tax Cycle**






# 2024 Adopted Balanced Budget








# Digest Over Time






## **Assessment Ratios**

# Real Property Digest Changes




## Typical Market Changes

- Residential: 189,844 properties: 6% or \$26,000 fair market value on average
- Commercial: 9,060 properties: 39% or \$906,000
   fair market value on average

## Residential vs Commercial Market Drivers

- Residential: Home values continued to have more rapid price increases until a slow down in 2022 3<sup>rd</sup> quarter. Price increases slowing, though increasing. 4.8% statutory freeze after appeal (up from 4.3%)
- Commercial: All commercial types show increases, with multifamily, and distribution being strongest sectors. 12% statutory freeze after appeal (down from 17%)


