Proclamation

RECOGNIZING THE GREAT AMERICAN SMOKEOUT

November 21, 2024

WHEREAS, The Great American Smokeout is an annual initiative led by the American Cancer Society that encourages individuals across the United States to quit smoking and start a healthier, smokefree lifestyle; and

WHEREAS, According to the American Cancer Society, quitting smoking before the age of 40 reduces the risk of dying from smoking-related diseases by 90% and has many other financial, health, and well-being benefits; and

WHEREAS, Tobacco use is an important public health battle in Georgia, as more than 1 million adults, 53,000 high school students, and 14,000 middle school students in Georgia smoke cigarettes; and

WHEREAS, Smoking also contributes to an estimated 480,000 deaths nationwide every year, or about 1 in 5 deaths, and costs Georgians a total of \$1.8 billion in direct health care costs as well as \$3.4 billion in lost productivity every year; and

WHEREAS, On November 21, 2024, Gwinnett United in Drug Education invites smokers to join the movement to guit smoking or make a plan to guit during the Great American Smokeout; and

WHEREAS, Gwinnett County encourages all residents to celebrate the Great American Smokeout by leveraging support, resources, and motivation to overcome their addiction to tobacco or to help loved ones quit.

NOW, THEREFORE, I, Nicole Love Hendrickson, on behalf of the Gwinnett County Board of Commissioners, do hereby proclaim November 21, 2024, as the Great American Smokeout in Gwinnett County. I encourage all residents to support friends or family members who want to quit smoking by offering assistance, understanding, and encouragement.
