Revisions:

- R1. Section A (Police) has been revised. **Please see the attached REVISED BID SCHEDULE.** Please note: the Revised Bid Schedule only applies to Section A (Police). Please submit Section B using the original Invitation to Bid.
- R2. Page 33, Section B, Line Item 29 of the Invitation to Bid. This line item requires patches to be sewn on, NOT silkscreening.

Clarification:

- C1. Delete Section B, Line Item 19, "Augusta Sportswear Longer Length Jersey Shorts, Style 915 or equivalent, Navy Blue, No Silkscreen" and replace with "Russell Basic Cotton Pocket Shorts, Style 25843M or equivalent, Navy Blue, No Silkscreen"
- C2. For Section A, the approximate annual quantities listed in the Revised Bid Schedule are the average annual quantities over the life of the contract. Due to uniform redesign, quantities for year 1 will be higher than the listed average. **During year 1, the Police intends to supply approximately 4 uniforms per 700 staff members.**
- C3. Artwork is provided in the attached Graphics Appendix. Artwork may be changed or added throughout the life of the contract. At times, the awarded supplier may be asked to assist in the design of artwork (including thread color). All artwork remains the property of Gwinnett County Board of Commissioners and upon completion of this contract shall be returned to the appropriate user department.

Please see the below summation of questions and answers for the above solicitation.

Questions:

- Q1. Can suppliers provide screen print and embroidery prices separately from the garment prices? Our prices vary based on logo size, number of stitches, number of colors, and stitch count.
A1. No, all costs associated with the purchase (including fittings, delivery, embroidery, etc.) should be included in unit price. Artwork details are provided in Graphics Appendix.
- Q2. Can the County provide images of all logos/decorations that will be used?
A2. Please see the attached Graphics Appendix.
- Q3. Can the County provide the required size for all logos/decorations?
A3. Please see the attached Graphics Appendix.
- Q4. Is there a minimum stitch count required for the embroidery of the logos?
A4. There is not a minimum stitch count but will require quality embroidery. Digitized versions of the artwork will be provided to the awarded supplier.
- Q5. Augusta Sportswear Longer Length Jersey Shorts, Style 915 appears to be discontinued. Is there a replacement item the County would like instead?
A5. Please see C1.
- Q6. On the Bid Schedule Section A, Item #10 says to put the police logo on left chest but does not say if it is screen print or embroidery. Can the County please clarify?
A6. Embroidery.
- Q7. On the Bid Schedule Section A, Item #38-45 all have the same garment style number. Can the County please clarify which item is being requested for each item?
A7. Please see the Revised Bid Schedule.
- Q8. Several of the line items like Bid Schedule Section A, Items #10, #11, and #12 say they need decoration, but do not specify screen print or embroidery. Can the County please clarify which method of decoration will be required for each line item?
A8. Please see the Revised Bid Schedule.
- Q9. Are there any items that will require both screenprinting and embroidery on them? If so, can the County please specify?
A9. No.
- Q10. Is there a specific kind of patch that the County wants used?
A10. All required patches will be provided to the awarded supplier(s) at time of order.
- Q11. Can suppliers submit this bid online via email?
A11. No, per Page 1 of the Invitation to Bid, "Bids should be typed or submitted in ink and returned in a sealed container marked on the outside with the BL# and Company Name"
- Q12. Are the four (4) additional one-year options to renew based on mutual agreement between the County and awarded supplier(s)?
A12. Renewal rates (increase or decrease) should be indicated on Page 36.
- Q13. Can the County confirm that the supplier will not need to make patches, emblems, and silk screens for garment decoration?

A13. Patches and emblems will be supplied to the awarded supplier(s) for application. Embroidery and screenprint will be completed by the awarded supplier(s).

Q14. Instead of in person fittings, can suppliers provide size charts for each item?

A14. If in person fittings are not possible, suppliers can provide uniform samples of all uniform sizes and uniform fittings will be done by County personnel and the information provided to the awarded supplier(s).

Q15. To get a better idea of the time and staffing needed for the fittings, can the County provide how many employees will need to be fitted for each department?

**A15. Sheriff: Approximately 912 authorized Sheriff's Office staff members
Police: Approximately 750 employees**

Q16. Since we have an office in Gwinnett County, could Gwinnett County employees come to our office for the fittings?

A16. No.

Q17. Does the cost of shipping need to be included in pricing? What if the supplier has an office in Gwinnett County?

A17. Yes, all cost associated with the purchase (including shipping and delivery) should be included in unit prices if applicable. In person delivery should be coordinated with the user departments.

Q18. Does the cost of the fittings need to be included in the garment pricing or can suppliers include that cost separately?

A18. Please see A1.

Q19. If suppliers are delivering the items via FedEx, UPS, etc. is Auto Liability Insurance required?

A19. No, insurance is only required for onsite fittings and/or delivery.

Q20. What are your payment terms?

A20. Net 30

Q21. How long from order placement does Gwinnett County expect delivery of the garments?

**A21. Sheriff: 30-45 days
Police: Please see C2. Complete roll out should be completed within 4-6 months of issuance of PO. All other orders should be completed by the supplier's delivery ARO specified in the supplier bid.**
