NOTICE OF BID BL095-24, Gwinnett County Gateway Monuments Project

The Gwinnett County Board of Commissioners is soliciting competitive sealed bids from qualified contractors for the **Gwinnett County Gateway Signs Project**.

Bid submittal date and location:

Sealed bids will be received by the Gwinnett County Department of Financial Services - Purchasing Division-2nd Floor, 75 Langley Drive, Lawrenceville, Georgia 30046 until 2:50 P.M. local time on August 21, 2024 and then publicly opened and read aloud at 3:00 P.M. Any bid received after 2:50 P.M. will not be accepted. Bid envelope must be marked on the outside with Bid Number, name of Bidder, date and time of opening. Contractor providing the utility work must have a current valid Utility Contractors License.

Project Description:

The scope of this project includes, but is not limited to, the construction of new Gateway Monuments in Gwinnett County, Georgia, along with limited site work and finish landscaping. The signage is a prototype gateway monument sign, which will be site adapted at multiple locations throughout the County. The scope of this project includes two (2) of those locations. One sign will be located in the northbound Right of Way of I-85 at Exit 99 Jimmy Carter Boulevard. The other sign will be located in the Right of Way of State Route 124 at Riverlake Way. Site location plans are included in the Bid Drawings. The sign is constructed on a shallow mat foundation. The main sign support structure is a steel tubular frame anchored using 1" anchor bolts embedded in the concrete foundation. The Base of the sign is constructed using partially reinforced CMU with a surface applied Granite Veneer and formed aluminum cap with textured coating. The main sign is an internally illuminated aluminum frame construction. Electrical and lighting are included in the scope of this Work.
