## **QUESTIONS & ANSWERS:**

- Q1. Are alternate turf manufactures approved, providing all required turf specifications are met?
- A1. Yes, alternates will be accepted as long as they meet all required specifications.
- Q2. Is onsite disposal of existing turf via roll-off dumpster permitted?
- A2. No, onsite disposal via roll-off dumpster shall not be permitted.

### Q3. Can we reuse current infill and top it off with new infill?

A3. The existing infill shall not be reused. The awarded contractor shall dispose of the existing infill properly and new infill shall be provided as defined in the specifications.

### Q4. Who did the original installation?

A4. The original installation was done by Deluxe Athletics.

### Q5. What is the timeline for the project?

- A5. The County anticipates award in mid-October, with the Notice to Proceed expected in late October or early November 2024.
- Q6. On C300, there are 3 different call outs for the combination football/soccer goal please clarify which of the indicated equipment specifications is correct.
- A6. The specified product is part number GPKR30ADJ. Please see Attachment A (Goal System Specification) for additional information.


