QUESTIONS & ANSWERS:

- Q1. What is line item (2) Asphalt Repair Superpave Customized?
- A1. "Customized" shall be removed from the description of line item #2. Line item #2 shall be revised to "Asphalt Repair Superpave."
- Q2. Line item (5) Flex Pave: Is that considered permaflex?
- A2. Yes.
- Q3. Is there a list of the parks and trails that we would be working on?
- A3. There is not a comprehensive list available at this time. There is generalized information regarding Gwinnett County Parks on the Gwinnett County website. Work shall be determined on an as-needed basis by the Department of Community Services.
- Q4. Will trail repairs be accessible for equipment?
- A4. Yes
- Q5. If tree removal or clearing and grubbing is needed to access trail, what line item will that be paid under?
- A5. Section D; Item # 2; Hourly rate for 2-man crew.
- Q6. Will a lot of the parking lots require slurry seal/coating?
- A6. At this time, the County anticipates minimal use of this item.
- Q7. What percentage of repairs are trail repairs and what percentage are parking lot repairs?
- A7. Quantitative information is not available at this time. Work shall be determined on an as-needed basis by the Department of Community Services.
- Q8. What is the average size of trail repairs?
- A8. Quantitative information is not available at this time. Work shall be determined on an as-needed basis by the Department of Community Services.
