Addendum No. 2 BL127-24 Purchase of Rubber Floor Tiles

The following addition/changes modify the Bid No. BL127-24 "Purchase of Rubber Floor Tiles" Contract Documents, dated September 2024, as first advertised on September 25, 2024.

I. Questions:

- Q1. Will the materials be delivered to one location or multiple?
- A1. Materials will be delivered to one location. Delivery will be F.O.B. Destination, freight pre-paid and allowed to: Gwinnett County Department of Water Resources Central, 684 Winder Highway, Lawrenceville, GA 30045-5012.
- Q2. Will the facility have a loading dock/forklift, and an area large enough to accommodate a full-size trailer?
- A2. Yes, if needed.
- Q3. For equivalent substitutions. Shall they be submitted with the bid or prior for approval?
- A3. Requests for approval of an "approved equivalent" product will only be evaluated following the Bid opening. Approval of any "or equal" products submitted for consideration will be at the Owner's sole discretion.
- Q4. Roppe has said that Divergent 574 is not one of their products. Ps-525 Modified Pressure Sensitive adhesive is what is recommended with this product. Please confirm this is acceptable.
- A4. The provided glue (Divergent 574) was recommended as an adhesive in the case of moisture in the concrete. If Roppe has a product that is equivalent, please provide product information with bid submittal to be reviewed by Gwinnett County.
- Q5. Please clarify the unit of measurement for the tiles. Is Gwinnett County requesting 11,400 SF or 11,400 Tiles (which would be 45,600 SF)? 11,400 sq foot.
- A5. Gwinnett County is requesting bids for 11,400 SF of tiles. Please use the attached revised bid schedule that requests 11,400 SF instead of 11,400 EA.
