The following addition/changes modify the Bid No. BL125-24 "F. Wayne Hill Water Resources Center Secondary Clarifier 6 Repairs" Contract Documents, dated October 2024, as first advertised on October 16, 2024.

I. Modifications:

M1. In the Notice of Bid, under the paragraph Bid Submittal Date and Location, CHANGE the date shown from "~~November 15, 2024~~" to "**November 22, 2024**". This date change should also be changed throughout the Frontend documents.

II. Questions:

Q1. What is the estimated construction budget?

A1. There is approved funding for this project. Gwinnett County expects each contractor to bid a competitive price. Award will be made to the lowest responsive and responsible bidder.

Q2. Would Gwinnett County consider adding Envirodyne Systems, Inc. to the listed manufacturers in Part 2.1 B of Spec Section 46 4321, Page 5.

A2. Requests for approval of an "approved equal" product or manufacturers will only be evaluated following the Bid opening. Approval of any "or equal" products or manufacturers submitted for consideration will be at the Owner and Engineer's sole discretion.

Q3. Please confirm if the Contract Agreement must be executed and turned in with the bid package.

A3. The contract agreement does not have to be executed upon bid submittal. However, all Bidders are required to submit a Bid Bond or a certified check made payable to the Gwinnett County Board of Commissioners in the amount of five percent (5%) of the total amount bid.

Q4. Please provide the plan holders list.
