The Gwinnett County Board of Commissioners is soliciting competitive sealed bids from qualified contractors for the **Gwinnett Aquatic Centers Pool Pak Replacements** for the Gwinnett County Department of Community Services.

Bid submittal date and location

Bids should be typed or submitted in ink and returned in a sealed container marked on the outside with the BL# and Company Name. Bids will be received until **2:50 P.M. local time on December 4, 2024** at the Gwinnett County Purchasing Division, 75 Langley Drive, Lawrenceville, Georgia 30046. Any bid received after this date and time will not be accepted. Bids will be publicly opened and read at 3:00 P.M. Apparent bid results will be available the following business day on our website www.gwinnettcountv.com.

Pre-Bid Conference

A **pre-bid conference** is scheduled for 10:00 a.m. on **November 13, 2024** at the Gwinnett County Mountain Park Aquatic Center, 1063 Rockbridge Road, Stone Mountain, GA 30087. All contractors are urged to attend. West Gwinnett Aquatic Center, located at 4488 Peachtree Industrial Boulevard, Norcross, GA 30071, and Bogan Park Aquatic Center, located at 2723 N. Bogan Road NE, Buford, GA 30519, will be available for contractors to view the sites from 12:00 p.m. until 4:00 p.m. on November 13, 2024.

Project Description

Removal and replacement of pool pak units (1 at each location) at Mountain Park and West Gwinnett Aquatic Centers and associated mechanical improvements, with an Add Alternate to remove and replace 2 pool pak units at Bogan Park Aquatic Center, per plans and specifications.

Bonding and Insurance

All contractors must submit with bid, a bid bond, certified check or cashier's check in the amount of five percent (5%) of the total bid. Failure to submit a bid bond with the proper rating will result in the bid being deemed non-responsive. Successful contractor will be required to meet insurance requirements, submit a one hundred percent (100%) performance bond and a one hundred percent (100%) payment bond. Insurance and Bonding Company should be licensed to do business by the Georgia Secretary of State, authorized to do business in Georgia by The Georgia Insurance Department, listed in the Department of Treasury's Publication of Companies holding Certificates of Authority as Acceptable Surety on Federal Bonds and as acceptable

reinsuring companies. The bid bond, payment bond, and performance bond must have an A.M. Best rating of A-8 or higher.

Facility Access

Gwinnett County does not discriminate on the basis of disability in the admission or access to its programs or activities. Award will be made to the contractors submitting the lowest responsive and responsible bid. This project may be awarded by base bid or base bid plus selected alternates, if applicable, as deemed in the best interest of the County. Gwinnett County reserves the right to reject any or all bids to waive technicalities and to make an award deemed in its best interest. Bids may be split or awarded in entirety. Gwinnett County reserves the option to negotiate terms, conditions and pricing with the lowest responsive, responsible bidder(s) at its discretion.

Award notification will be posted after award on the County website, www.gwinnettcounty.com and companies submitting a bid will be notified via email.
